

# DUDLEY D. SHOENFELD (1893-1971) PAPERS ARCHIVES FINDING AID

#### **BIOGRAPHY**

Dr. Dudley D. Shoenfeld was born in New York City on 24 March 1893. He took his MD degree at Bellevue Medical College in 1917. He interned at the U.S. Naval Hospital in Chelsea, Massachusetts, Massachusetts General Hospital, Boston City Hospital and Peter Bent Brigham Hospital. He was child psychiatrist with the Jewish Board of Guardians; clinical assistant at Mount Sinai Hospital; consulting psychiatrist at the Hebrew Orphan Asylum; and had a private practice of psychiatry and psychoanalysis. He taught at the Nurse Training School of Mt. Sinai Hospital and the New School for Social Research on Child Guidance. He was a member of the American Psychiatric Association, the American Medical Association, and the American Psychoanalytic Association. Dr. Shoenfeld was a member of the Mayor's Commission on Marijuana from 1939 to 1941 and served the City of New York in other capacities as well.

#### **SCOPE AND CONTENTS**

The papers of Dudley Shoenfeld came to the Archives of the American Psychiatric Association in 1974 from his family. The collection totals .50 linear feet and is comprised of one series: miscellaneous papers. These papers deal with his involvement with the Mayor's Commission and other substance abuse/juvenile delinquency issues.
